REQUIREMENTS FOR ISSUANCE OF A SEVIS I-20

In compliance with United States Citizenship and Immigration Services (USCIS) regulations, the Office of International Students and Scholars (OISS) requires valid financial documentation supporting your request for a SEVIS I-20. Acceptable financial documents include:

➤ ***Personal funds***

A recent bank statement(s) or Certificate of Deposit verifying that you have access to the amount of money required for your academic program. Online print-outs and ATM receipts are not acceptable documents.

➤ ***Funds from UCLA***

A copy of scholarship, fellowship, grant, or assistantship award letters or a letter specifying the type, amount, and duration of award from the appropriate department.

➤ ***Family funds from abroad***

A recent bank statement(s) with a letter written by the person listed on the bank statement confirming the funds are intended for your educational expenses OR bank letters verifying that you receive the required amount of money from your family during the academic year.

➤ ***Your government or other sponsoring agency***

A signed copy of the scholarship or award letter which states the amount and duration of the award.
